

Again with an error log with errors there will be information that will not be important in checking the error log. Begin by looking for information that comes after the line titled --

**\*\* START OF TRANSACTION SET**

If there are errors you will see the errors documented below this line. In the file above there are three errors. All errors will appear above the ERROR = lines. Two in the pre-check and one in the post-check. The error counts reflect this ERRORS = 2 and ERRORS = 1

The file's errors will need to be corrected and the entire file will need to be resubmitted to ABH.

## Reading Error Lines

Below is an example of an error line:

**D6 : Data element type error (VD8..17) (D.E.1250 PO: 2 2400/DTP PO: 0152 )  
RECORD #28 : DTP\*472\*RD8\*Date-20050228**

**D6:** This element of the error line can be ignored.

**Data element type error:** The beginning of the line is the description of the error. In this case the wrong type of data was submitted, instead of a date the word date was entered.

**(VD8..17):** This is the data type that the element should be. VD or D=date, A=alphanumeric, and I=integer. The number indicates the minimum and maximum length allowed. In this case the minimum is eight and maximum is 17.

**(D.E. 1250:** This is the data element number (a number that is referenced in the national standards).

**PO: 2:** This is the position of the element within the error line.

**2400/DTP:** This is the loop and segment within file containing the error.

**PO:0152:** This number can be ignored, it references an internal mapping number.

**RECORD #28:** This is the line number of the line in the file submitted.

**DTP\*472\*RD8\*Date-20050228:** This is an actual copy of the line of data that contained the error.

All errors need to be corrected. Once they are corrected, resubmit the file to ABH and the file will be checked. Another error log will be created indicating if there are any additional errors.
